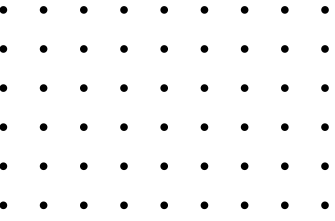

# OVERVIEW:

This report is designed to provide the latest data on substance use disorder (SUD) indicators. The report includes charts and tables for over 16 indicators of county risk factors associated with the development of SUDs, and an additional nine supplemental indicators are provided at the end of the document. Through the assistance of our partner state agencies, we have included research-based data indicators that are typically associated with SUDs. The framework for reporting these indicators is intended to provide a simple tool for county planners to utilize when making data-driven decisions in support of prevention and treatment planning activities. To provide the best results, we recommend that the report be used in conjunction with other local knowledge resources.

# ORGANIZATION OF THIS REPORT:




The first section of the report includes the county profiles, each with its appropriate percent changes from the previous year's results. Indicators are organized into the following data domains:

- **Alcohol:** This domain covers indicators related to alcohol consumption and its consequences, including binge drinking, heavy alcohol use, DUI crashes, and alcohol-related hospital encounters. It helps assess the prevalence of alcohol misuse and its public health impact.
- **Nicotine:** This domain includes data on tobacco and nicotine use, such as cigarette smoking, smokeless tobacco, and e-cigarette use among adults. It highlights patterns of nicotine consumption and potential health risks.
- **Opioids:** Focused on opioid use and its outcomes, this domain includes indicators such as naloxone administration, opioid prescriptions, overdose deaths, and opioid-related hospital encounters. It provides insight into the opioid crisis and response efforts.
- **Stimulants:** This domain tracks stimulant use, including methamphetamine and prescription stimulant misuse. It includes data on overdose deaths and prescription monitoring to assess trends and risks associated with stimulant substances.
- **Infectious Disease:** This domain examines infectious diseases associated with substance use, such as HIV, tuberculosis (TB), and viral hepatitis, particularly among people who inject drugs (PWID). It helps identify public health concerns and intervention needs.
- **Social:** Covering broader social determinants of health, this domain includes factors like unemployment, high school graduation rates, child maltreatment, homelessness, and suicide. These indicators provide context on how social conditions influence substance use and overall well-being.

Supplemental data is located in the Appendix and includes information on other drugs and infectious diseases.

# APPENDIX

This section provides additional data on client substances using the same ranking methodology. However, it is not categorized within a specific domain or as a standalone domain, as it includes mortality data that is not exclusive to a single cause. As a result, opioid-related data might be duplicated and carry more weight in final county rankings if included.

The indicators for alcohol-related and opioid-related hospital encounters reflect instances where individuals experienced a medical event associated with substance use and were transported to a hospital by EMS or other means. These indicators are based on hospital visit data but do not confirm patient discharge status or final medical outcomes. Please note that statewide hospital encounters on the Statewide sheet are referring to the total count of records for that particular substance.

The purpose of these indicators is to provide insight into the burden of alcohol- and opioid-related medical emergencies that require hospital care. The data can help inform public health efforts by identifying trends in emergency responses and hospital utilization due to these substances.

Additionally, infectious disease data is included in this appendix due to the increased risk of certain conditions associated with substance use, particularly among individuals who inject drugs.

# INTERPRETATION

This report is for informational purposes only. There are a variety of measures to consider when analyzing substance use burden, and the chosen indicators are one of many options available. Readers are encouraged to use discretion when analyzing the report and to consider additional factors that might not be included, as well as regional context (including local reporting practices).

# LIMITATIONS

While this report may provide insight on indicators and risk factors associated with substance use disorders (SUDs), there are several limitations to consider when using this report:

- **Data Availability and Completeness:** Not all counties report data consistently or comprehensively across all indicators. In smaller counties, data may be incomplete or unavailable, which can affect the report's overall comprehensiveness.
- **Timeliness of Data:** Many data sources used in this report may not reflect the most current trends due to delays in reporting and processing. As a result, various data ranges have been used across indicators. For more detailed information on the availability of specific data sources, please refer to page 4 of this report.
- **Data Exclusion:** Certain data may have been excluded from the report due to inconsistent reporting, unavailability across counties, or insufficient sample sizes. For example, while cannabis use is of interest to stakeholders, there is currently not enough county-level data to include this indicator in the report.
- **Data Collection Methods:** This report offers a cross-sectional view of indicators and risk factors related to SUDs. As such, it should not be used to infer causality regarding SUDs. Additionally, the methods used for data collection and reporting may vary across counties, which can affect the consistency of the data.
- **Geographic Variability:** Geographic variability in data collection and interpretation may impact the consistency of results across counties, particularly between rural and urban areas or regions with differing access to healthcare and public health services.
- **Data on Private SUD Service Providers:** This report does not include data from private substance abuse treatment providers. The focus is primarily data sources DAODAS has access to. The absence of information from private providers may limit the comprehensiveness of the SUD landscape, particularly in areas where private treatment options are prevalent. Pages 57-62 provide data reported by the state's publicly funded county alcohol and drug authorities.

These limitations should be taken into account when using this report to support data-driven decision-making in SUD prevention and treatment planning. Despite these challenges, the data remains a valuable resource for understanding county-level trends and guiding public health efforts.

# DATA DICTIONARY- ADDITIONAL NOTES

## POPULATION REFERENCE

The 2023 population figure reflects an estimate based on the 2020 decennial census conducted by the U.S. Census Bureau. This agency describes the methodology of estimation by taking the base population (2020 census) and crafting an estimate through available birth, mortality, and migration data. Use of a different estimate, including a different census year, will impact rate calculation. This might address the difference in rate calculations in this report compared to other sources.

## MORTALITY

Mortality Fatal Drug Overdose data is provisional data and describes fatal drug overdose deaths that occurred in South Carolina in 2021. Upon its publication, see the Department of Public Health's final Vital Statistics report for the most up-to-date rates for South Carolina. Drug overdose deaths are identified using underlying cause-of-death codes from the 10th revision of the International Classification of Diseases (ICD-10): X40-X44 (unintentional), X60-X64 (suicide), X85 (homicide), and Y10-Y14 (undetermined). Drug overdose deaths involving selected drug categories are identified by additional multiple cause-of-death codes. The current "prescription drugs" category includes both opioid and non-opioid prescription drugs. The category "opioids" includes both legal and illegal opioids. Prescription drugs are identified by the following ICD-10 codes: T36.0-T39.9, T40.2-T40.4, T41.0-T43.5 and T43.7-T50.8. Opioids are identified by codes T40.0-T40.4, T40.6. Other codes used are: heroin (T40.1), methadone (T40.3), and cocaine (T40.5). Fentanyl is identified through a search of the literal cause of death. Psychostimulants with abuse potential, which include such drugs as methamphetamine, amphetamine, methylphenidate (Ritalin), and 3,4-methylenedioxy-methamphetamine (MDMA, ecstasy), are identified by the code T43.6.

Drug overdose deaths may involve multiple drugs; therefore, a single death might be included in more than one category when describing the number of drug overdose deaths involving a specific drug. For example, a death that involved both heroin and fentanyl would be included in the following categories: deaths involving heroin, deaths involving fentanyl, deaths involving opioids, and deaths involving prescription drugs.
